14 15	WHEREAS, Staff has determined that the City's sewer collections system is
16	inundated with rags and debris that clog and damage pumps; and
17	
18	WHEREAS, lift station #14, located at 295 NW 10th Terrace, has had to be placed
19	on bypass multiple times in the last six months and the buildup of rags around the impellers
20	has required extensive work on the pumps at this lift station; and
21	
22	WHEREAS, one of the mitigation aspects of the operational strategy for the life
23	station requires the installation of a grinder pump to reduce the damage to the pumps and
24	equipment caused by such rags and debris, and staff believes that doing so offers the City
25	the best opportunity to keep the lift station functioning effectively; and
26	
27	WHEREAS, staff recommends utilizing August 7, 2018, Pinellas County, Florida
28	and TLC Diversified, Inc. entered into a contract pursuant to Pinellas County's Bid No
29	178-0360-CP(JJ), for Repair, Rehabilitation and Improvements to Sanitary Sewer pump
30	Stations pursuant to Section 23-8(6), City of Hallandale Beach Code of Ordinances, as ar
31	exception to the Code's Section 23-4 competitive solicitation requirements; and

33	NOW, THEREFORE, BE IT RESOLVED BY THE MAYOR AND THE CITY
34	COMMISSION OF THE CITY OF HALLANDALE BEACH, FLORIDA:

36	SECTION 1. The foregoing "Whereas" clauses are incorporated herein.

The Mayor and City Commission hereby authorize use, pursuant to Section 23-8(6), City of Hallandale Beach Code of Ordinances, of the competitively solicited Source Contract dated August 7, 2018 between Pinellas County, Florida, and TLC Diversified, Inc. for Repair, Rehabilitation and Improvements to Sanitary Sewer pump Stations to purchase and install a submersible pump with grinder option lift station #14 in an amount not to exceed ninety nine thousand, five hundred and fifty four (\$99,554.00) dollars as set forth in the attached Agreement incorporating the City of Hallandale Beach's Terms and Conditions and Insurance Requirements. The City Manager is authorized to negotiate and execute an agreement to effectuate this authorization. **SECTION 3.
