29 30	SECTION 2. COMPOSITION OF ADVISORY BOARD		
31	A. The Advisory Council to the Board of Directors of the Three Islands Safe		
32	Neighborhood District shall be comprised of seven (7) members who are residents of the District		
33	B. The members shall be at-large appointments made by the Board of Directors, who		
34	shall request nominations from the associations of the district. Every effort shall be made to		
35	appoint no more than one individual from any single association. All appointees serve at the will		
36	of the Board of Directors.		
37	C. Four (4) Advisory Council Members shall constitute a quorum for the conduct of		
38	the Advisory Council's business.

41	SECTION 3. The Advisory Council shall perform such duties as may be prescribed by the			
12	Board of Directors and shall include the following:			
13	A.	Review, in an advisory capacity, in public session, with City representatives, a Safe		
14		Neighborhood Improvement Plan, District Budget and improvements, District By-laws		
15		and related matters, for consideration and approval of the Board of Directors.		
16	В.	Consult with City representatives at least once per year regarding the Safe		
17		Neighborhood Plan for the District, the District Budget and improvements, and related		
18		matters.		
19	C.	Prepare an annual report on the District's activities within a time specified by the Board		
50		of Directors.		
51	D.	In fulfillment of duties, request City Manager assistance through the Board of Directors.		
52	E.	Prepare a written report for the Board of Directors of the proceedings of all Advisory		
53		Council meetings.
