4 A RESOLUTION OF THE MAYOR AND CITY COMMISSION  
5 OF THE CITY OF HALLANDALE BEACH, FLORIDA,  
6 ADOPTING THE "2021 STATE LEGISLATIVE PROGRAM"  
7 AS ITS LEGISLATIVE PRIORITIES; AUTHORIZING THE  
8 LEGISLATIVE PROGRAM TO BE PRESENTED TO THE  
9 BROWARD COUNTY STATE LEGISLATIVE DELEGATION  
10 FOR CONSIDERATION DURING THE 2021 LEGISLATIVE  
11 SESSION AND TO GIVE DIRECTION TO BALLARD  
12 PARTNERS, INC. AS THEIR PROGRAM; AND PROVIDING  
13 AN EFFECTIVE DATE.

16 **WHEREAS**, annually, the City Commission discusses various issues for submittal  
17 to the Broward County Legislative Delegation and State Legislators for consideration  
18 during the legislative session; and  
19

20 **WHEREAS**, as there are many issues that are significant to the City, it is imperative  
21 to prioritize those issues that are most important and to focus its energy in ensuring the  
22 constituent voices are heard at the County and State; and

24 **WHEREAS**, the City Administration has reviewed prior priorities and the current  
25 needs of the City and based on this year's discussions recommend that the Mayor and  
26 City Commission adopt as the priorities for the City, to be presented to the Legislative  
27 Delegation, as detailed in the attached "2021 State Legislative Program"; and

29 **WHEREAS**, these priorities serve to guide the City Commission, City  
30 Administration, the City's lobbyist, and the legislators in pursuing legislation which  
31 addresses these priorities and other related matters on behalf of the City and its residents;

34 **WHEREAS**, the City Administration recommends that the Mayor and City  
35 Commission adopt the proposed City of Hallandale Beach's 2021 State Legislative  
36 Program as its legislative priorities.

38 **NOW, THEREFORE, BE IT RESOLVED BY THE MAYOR AND CITY**  
39 **COMMISSION OF THE CITY OF HALLANDALE BEACH, FLORIDA:**

41 **SECTION 1.** The foregoing "Whereas" clauses and referenced exhibits and

42 attachments are incorporated herein.

44 **SECTION 2. City Manager Authorization.** The Mayor and City Commission  
45 adopts the attached City of Hallandale Beach's "2021 State Legislative Program" as being  
46 in the best interest of the City and its residents and further authorize the City Manager to  
47 take the necessary steps to cause a copy of this resolution to be forwarded to the Broward  
48 County Legislative Delegation and State Legislators for consideration during the  
49 legislative session.

51 **SECTION 3. Effective Date.** This Resolution shall take effect immediately upon  
52 its passage and adoption.
