SHORT TITLE:

A RESOLUTION OF THE MAYOR AND CITY COMMISSION OF THE CITY OF HALLANDALE BEACH, FLORIDA, AUTHORIZING UTILIZATION OF THE CITY OF FORT LAUDERDALE'S CONTRACT WITH SOUTHEASTERN ENGINEERING CONTRACTORS, INC., FOR MAINTENANCE OF LARGE DIAMETER STORM WATER PIPES IN AN AMOUNT NOT TO EXCEED TWO HUNDRED SEVENTY ONE THOUSAND, FIVE HUNDRED AND THIRTY DOLLARS (\$271,530); AUTHORIZING CITY MANAGER TO EXECUTE RELATED DOCUMENTS; AND PROVIDING AN EFFECTIVE DATE.

STAFF SUMMARY:

Summary:

This agenda item seeks City Commission's approval to retain the services of Southeastern Engineering Contractors, Inc. for the maintenance of large diameter storm water pipes citywide utilizing the City of Fort Lauderdale's contract with Southeastern Engineering Contractors, Inc. through Invitation to Bid (ITB) No. 473-11907 (Exhibit 3) for an amount not-to exceed \$271,530.

Background:

Stormwater systems, often as a part of their operation, accumulate silt and debris over time. The infrastructure where this accumulation occurs is underground and requires a large-scale operation to effectively perform the cleaning.

While the City of Hallandale Beach has been routinely maintaining and cleaning the smaller diameter (15" and under) storm water pipes, City staff was never equipped nor had in place any means to clean the larger diameter pipe in the drainage system. The accumulation of debris and sediments inside these pipes reduces the effective flow of stormwater, which increases the opportunity of flooding hazards during rainy seasons.

Current Situation:

The southeast section of the city's underground stormwater piping is an integral part of our flood management operations. The southeast system connections directly flow through underground infrastructure out of the area through outfalls that discharge into the intercoastal waterway. The effective functionality of this system is a necessary part of our strategy to remove stormwater from the City. Southeastern Engineering Contractors, Inc. submitted the attached proposal for an amount of \$271,530 (Exhibit 2).

The term of the original contract (Exhibit 3) expired on June 9, 2019. The City of Fort Lauderdale has exercised its right to extend the contract with Southeastern for the two (2) one (1) year renewal term stipulated in Section 15.1 of the contract. which extends the term to June 19, 2021 (Exhibit 4).

Cost Benefit

The performance of this maintenance increases the efficiency of the system to remove stormwater from the area. It increases the opportunity to mitigate flooding in the area and reduces impacts to the homeowners. Additionally, performing this work is necessary to allow the stormwater system to reach its designed life span.

PROPOSED ACTION:

City Commission to approve the attached resolution and authorize staff to retain the services of Southeastern Engineering Contractors, Inc. for the maintenance of large diameter stormwater pipe citywide utilizing the City of Fort Lauderdale's agreement with Southeastern Engineering Contractors, Inc. through the Invitation to Bid (ITB) No. 473-11907 for an amount not-to exceed \$271,530.


