SHORT TITLE:

A RESOLUTION OF THE MAYOR AND CITY COMMISSION OF THE CITY OF HALLANDALE BEACH, FLORIDA, AUTHORIZING USE OF THE BROWARD SHERIFF'S OFFICE AGREEMENT RLI #19053JLS WITH MOTOROLA SOLUTIONS INC., FOR THE PURCHASE OF EQUIPMENT, SERVICE INTEGRATION, AND INSTALLATION OF AUTOMATIC LICENSE PLATE RECOGNITION (ALPR) CAMERAS TO OUTFIT TWO (2) PARKING VEHICLES FOR AN AMOUNT NOT TO EXCEED SIXTY-FIVE THOUSAND FIVE HUNDRED FORTY-NINE (\$65,549) DOLLARS; AUTHORIZING THE CITY MANAGER TO EXECUTE ALL RELATED DOCUMENTS TO EFFECTUATE THE PURCHASE; AND PROVIDING AN EFFECTIVE DATE.

STAFF SUMMARY:

Summary:

Staff seeks approval to purchase four (4) Automatic License Plate Recognition (ALPR) cameras from Motorola Solutions Inc. to outfit two (2) parking vehicles. The ALPRs will help parking

enforcement specialists more efficiently and expeditiously identify vehicle tags with outstanding parking payments.

Background:

The ALPR cameras are specialized cameras with built-in software to help identify and record license plates. The parking ALPRs will compare the license plates on vehicles parked in City managed parking areas with the vehicle plates submitted into the City's parking payment software. The vehicle tags which have outstanding payments or did not pay for parking will be flagged alerting the parking enforcement specialist. As an added benefit, the information captured on the ALPR will also compare the plates to the Florida Department of Law Enforcement's database. This database, also known as the hotlist, is a compilation of license plates connected to criminal activity such as a stolen vehicle. When there is a match, Police (not the parking enforcement specialist) will be alerted and can immediately respond to intercept the vehicle.

Currently, the City of Hallandale Beach has six (6) ALPR cameras in the two Safe Neighborhood Districts. The ALPR cameras are at the entrances of the Three Islands Safe Neighborhood District and the entrance and exit of the Golden Isles Safe Neighborhood District. Furthermore, Motorola Solutions Inc. is currently installing ALPRs at eleven (11) entry and exit locations to capture vehicle traffic on the main traffic arteries around the City at a cost of \$479,000. An initiative approved by City Commission on December 16, 2020.

On September 9, 2019, the Broward Sheriff's Office (BSO) released a Request for Letters of Interest (RLI) #19053JLS for Base Layer Integration Platform for the Real Time Crime Center (see Exhibit 2). Responses were received from ten (10) vendors (See Exhibit 3). The BSO eventually awarded the contract to Motorola Solutions Inc. and executed the agreement on March 13, 2020 (See Exhibit 4).

Current Situation:

The HBPD intends to piggyback on the BSO contract with Motorola Solutions Inc. in order to purchase equipment, service integration and installation of the ALPRs. Further, the proposal includes all licensing agreements and a maintenance agreement to cover all service costs and labor for the next five (5) years (see Exhibit 5).

The purchase of this equipment will support the enhancement of the Parking Program, which is identified as a top priority project in this fiscal year. The expansion of the ALPR system will have an immediate impact on parking enforcement functions. The ALPR parking enforcement platform will alert parking enforcement specialists of violations when they drive past parked vehicles in City managed parking areas. This will allow the specialists to identify and cite parking violators more efficiently. Further, the ALPR will act as a force multiplier allowing the parking enforcement specialist to cover more territory faster.

Why Action is Necessary:

Pursuant to Chapter 23, Section 23-8 Exception to Bid Requirements, (6) Bids and Contracts from other entities, and Section 23-9 Cooperative Purchasing, the City Manager is authorized to procure all supplies, materials, equipment and services from other governmental units, when the best interests of the City would be served subject to the requirement that any purchase in excess of \$50,000 requires City Commission approval.

As the aforementioned purchase will be in excess of the City Manager's purchasing authority, City Commission authorization is required.

Cost Benefit:

The execution of the ALPR agreement with Motorola Solutions Inc. through a piggyback is the timeliest cost-effective procurement of this parking enforcement solution. This process is the optimum means to obtain this service.

PROPOSED ACTION:

The City Commission consider the attached Resolution executing the agreement between the City of Hallandale Beach and Motorola Solutions Inc. for the purchase of equipment, service integration, and installation of the parking ALPRs not to exceed \$65,549.
