18	WHEREAS, the City of Hallandale Beach and the International Union of Police
19	Associations (IUPA) Chapter 6029 have engaged in the collective bargaining process for the
20	purpose of negotiating an Agreement concerning the relations between employer and the
21	police officers/sergeants of the City of Hallandale Beach; and
22	WHEREAS, the Union and the City of Hallandale Beach are legally authorized and
23	encouraged by Chapter 447 of the Florida Statutes, known as the "Florida Collective
24	Bargaining Act" (CBA) to negotiate in good faith; and
25	WHEREAS, after several negotiation sessions a tentative proposed collective
26	bargaining agreement (Exhibit "A") has been reached between the City and PBA negotiation
27	team for the effective period of October 1, 2018 through September 30, 2020; and
28	WHEREAS, on March 26, 2021, the members of IUPA ratified the tentative proposed
29	agreement by majority vote of its members; and
30	WHEREAS, it is recommended that the City Commission ratify the terms, of said
31	Agreement as tentatively agreed upon by the negotiators and to authorize the City Manager
32	to execute said agreement and to implement the terms.
33	NOW, THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY
34	OF HALLANDALE BEACH, FLORIDA:
35	<b>SECTION 1.</b> City Commission Action. The Mayor and City Commission hereby
36	ratify the agreement between the City of Hallandale Beach and the International Union of
