22	Collection operation's fleet consists of six (6) trucks. Currently only three (3) trucks are
23	operational; and

25	WHEREAS, currently the Division is utilizing three (3) rental front loader refuse
26	trucks from Big Truck Rental, LLC, and it will continue to need the used of these vehicles
27	for the remainder of the fiscal year, and potentially beyond; and

29	WHEREAS, staff seeks approval to utilize the competitively solicited OMNIA
30	PARTNERS contract #2019-000319 with Big Truck Rental, LLC Inc. through the City of
31	North Carolina's RFP No. 269-2018-047 for the rental of the trucks; and

33	NOW, THEREFORE, BE IT RESOLVED BY THE MAYOR AND THE CITY
34	COMMISSION OF THE CITY OF HALLANDALE BEACH, FLORIDA:
