17 Commission appoint a Director, an Alternate and a Second Alternate to the Board of
18 Directors; and

21 voting delegate and an alternate to attend and vote at the annual business session; and

23 WHEREAS, the National League of Cities' by-laws require the appointment of a
24 voting delegate, and one (1) alternate, (if desired) to attend and vote at the annual
25 business meeting.
