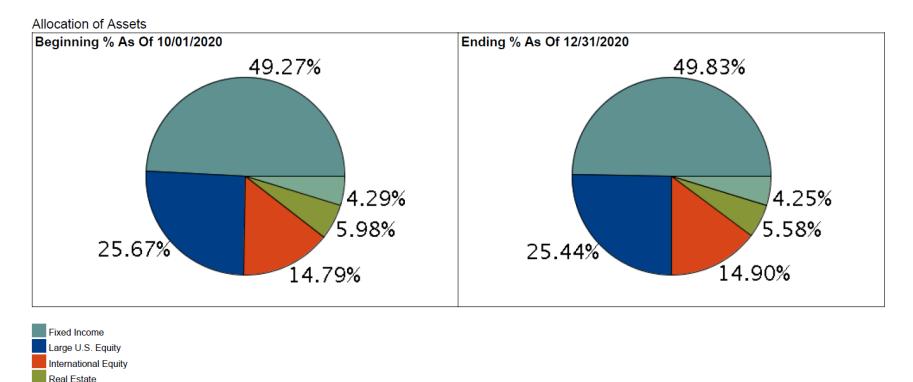

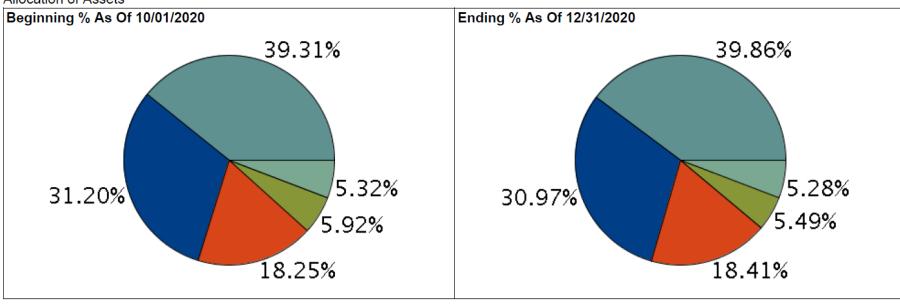

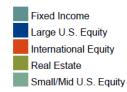

Target Asset Allocation – 40% Fixed Income

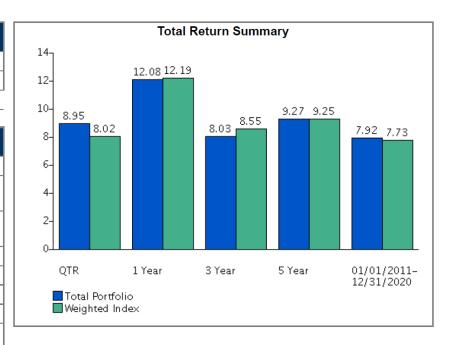
