

RESOLUTION NO. 2015 - 28

A RESOLUTION AUTHORIZING THE CITY MANAGER TO ENTER INTO A CONTRACT FOR A SOLID WASTE AND RECYCLING ASSESSMENT WITH KESSLER CONSULTING, INC. PIGGYBACKING ON AN AGREEMENT BETWEEN KESSLER AND THE CITY OF DEERFIELD BEACH, FLORIDA IN AN AMOUNT NOT TO EXCEED NINETY NINE THOUSAND SEVEN HUNDRED TWENTY DOLLARS (\$99,720.00); AND PROVIDING AN EFFECTIVE DATE.

WHEREAS, the 2014-2015 budget contains funds for the engagement of a consultant to conduct a thorough analysis of the City's solid waste and recycling operations in order to identify areas to improve efficiency and provide a cost effective service; and

WHEREAS, on January 11th 2011, the City of Deerfield Beach entered into an agreement with Kessler Consulting, Inc. ("Kessler Consulting") pursuant to RFQ #2010-11/02, and its scope of service satisfies the City's requirements for conducting an assessment and drafting a strategic plan to achieve efficiency and sustainability; and

WHEREAS, the City has reviewed the procurement procedures utilized by the City of Deerfield Beach and found them to be in accordance with the City's own procedure process; and

WHEREAS, the City has received authorization from both the City of Deerfield Beach and Kessler Consulting to enter into an agreement under the terms of the contract; and

WHEREAS, pursuant to Chapter 23 of the Code of Ordinances, Section 23-8(6), Bids and Contracts from other Entities, and Section 23-9, Cooperative Purchasing, authorize the City Manager to procure all supplies, materials, equipment and services from other governmental units, through formal written contracts when the best interest of the City would be served subject to the requirement that any purchase in excess of fifty thousand (\$50,000) dollars requires City Commission approval; and

WHEREAS, City Administration recommends that the Mayor and City Commission authorize the City Manager to enter into the contract, attached as Exhibit A, with Kessler Consulting, Inc. for a solid waste and recycling operations assessment in the amount of ninety nine thousand seven hundred twenty (\$99,720) dollars as it is in the best interest of the City.


32 NOW, THEREFORE, BE IT RESOLVED BY THE MAYOR AND THE CITY
33 COMMISSION, OF THE CITY OF HALLANDALE BEACH, FLORIDA:

34 **SECTION 1. Approval and City Manager Authorization.** The Mayor and the City
35 Commission hereby authorize the City Manager to enter into the contract piggybacking on an
36 agreement entered into pursuant to a competitive bid of the City of Deerfield Beach and Kessler
37 Consulting, Inc. to conduct an assessment of solid waste and recycling operations in an amount
38 not to exceed ninety nine thousand seven hundred twenty (\$99,720) dollars, and to approve
39 automatic renewal of the agreement upon the executed extensions by the City of Deerfield Beach.

40 **SECTION 2. Effective Date.** This Resolution shall take effect immediately upon its
41 passage and adoption.


