4 A RESOLUTION OF THE MAYOR AND CITY COMMISSION OF
5 THE CITY OF HALLANDALE BEACH, FLORIDA, AUTHORIZING
6 THE UTILIZATION OF THE CITY OF OAKLAND PARK'S
7 AGREEMENT NUMBER R2019-070 FOR SANITATION
8 CONSULTING SERVICES of KESSLER CONSULTING, INC. FOR
9 AN AMOUNT NOT TO EXCEED THIRTY-NINE THOUSAND SIX
10 HUNDRED FIFTY DOLLARS (\$39,650); AUTHORIZING THE CITY
11 MANAGER TO SIGN ALL RELATED DOCUMENTS; AND
12 PROVIDING AN EFFECTIVE DATE.

15 **WHEREAS**, pursuant to Chapter 23, Section 23-8 Exception to Bid
16 Requirements, (6) Bids and Contracts from Other entities, and Section 23-9
17 Cooperative Purchasing, the City Manager is authorized to procure all supplies,
18 materials, equipment and services from other governmental units, when the best
19 interests of the City would be served subject to the requirement that any purchase
20 in excess of \$50,000 requires City Commission approval; and

22 **WHEREAS**, the City of Oakland Park's competitively bid RFP No. 032919
23 for Solid Waste Continuing Consulting Services resulted in a contract between
24 Kessler Consulting, Inc. ("Consultant") and the City of Oakland Park dated July 1,
25 2019 (the "Source Agreement"), approved by the City of Oakland Park Resolution
26 Number R2019-070; and

28 **WHEREAS**, the City utilized the Consultant to review sanitation services
29 and prepare an RFP for multi-family and commercial collection; and
30

31 **WHEREAS**, Consultant is now being asked to revise the RFP document to
32 also include the outsourcing of residential accounts, and, has submitted a change
33 order to the existing scope of work to revise the RFP accordingly for an additional
34 amount of seventeen thousand ninety dollars (\$17,090); and

36 **WHEREAS**, there is a current encumbrance with a balance of \$22,560, and
37 the total revised scope of work amounts to thirty-nine thousand six hundred fifty
38 dollars (\$39,650); and

40 **WHEREAS**, City staff recommends that the City Commission approve the
41 requested change authorization for additional amount of seventeen thousand
42 ninety dollars (\$17,090) to include outsourcing of residential accounts, so that the
43 total not to exceed contract amount will be thirty-nine thousand six hundred fifty
44 dollars (\$39,650).

47 **NOW, THEREFORE, BE IT RESOLVED BY THE MAYOR AND THE**
48 **CITY COMMISSION OF THE CITY OF HALLANDALE BEACH, FLORIDA:**

50 **SECTION 1.** The foregoing "Whereas" clauses are incorporated herein.

52 **SECTION 2.** The Mayor and City Commission hereby authorize the
53 utilization of the City of Oakland Park's competitively bid RFP No. 032919 for Solid
54 Waste Continuing Consulting Services with Kessler Consulting, Inc., and approve
55 the requested change authorization for additional amount of seventeen thousand
56 ninety dollars (\$17,090), so that the total not to exceed contract amount will be
57 thirty-nine thousand six hundred fifty dollars (\$39,650); and authorize the City
58 Manager to sign all related documents.

60 **SECTION 3.** This Resolution shall take effect immediately upon its
61 passage and adoption.
