25	funds and resources to both parties; and

27	WHEREAS, the City Administration requests authorization to ratify the negotiated
28	settlement amount of sixty-nine thousand five hundred dollars and no cents (\$69,500.00)
29	in exchange for the execution of the appropriate release; and

31	WHEREAS, the Mayor and City Commission, being fully advised of the facts of
32	this matter, believe it is in the best interest of the City to resolve this litigation in lieu of
33	proceeding to trial and accepts the recommendation.
