DONATION AGREEMENT

THIS AGREEMENT is entered into as of the date of final execution below ("Effective date") by and between the CITY OF HALLANDALE BEACH, a municipal corporation organized under the laws of the State of Florida (hereinafter referred to as "CITY"), and 521 Golden Beach LLC, a Delaware limited liability company registered to transact business in Florida, (hereinafter referred to as "DONOR").

WHEREAS, DONOR wishes to make a donation to the CITY to comply with permitting requirements for development of beachfront property in a neighboring CITY; and

WHEREAS, CITY wishes to accept the DONATION, which has been approved by the City Commission by way of Resolution # , dated August 4, 2021.

NOW, THEREFORE, in accordance with the mutual promises contained in this Agreement and other valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the CITY and DONOR hereby agree as follows:

1. DONOR:

2. DONATION:

Description: Donation of material and installation of 5247.08 Cubic Yards of Sand, including all required permits, in accordance with Beach Fill Plan, attached hereto and incorporated herein as Exhibit A.

Value: The value of the donation is estimated to be \$200,000. This value is based upon historical costs for beach renourishment and adjusted for quantity and inflation.

4. **DONATION WARRANTY OF TITLE:** DONOR transfers all rights of ownership of DONATION listed on this Agreement to the CITY. DONOR shall deliver DONATION to the CITY free and clear of any liens, claims or other encumbrances of any type. This Section shall survive termination of this Agreement.

5. TERMS AND CONDITIONS:

- a. DONOR will place all sand landward of the seasonal high-water line.
- b. DONOR will obtain and pay for all permits required to effectuate the DONATION.
- c. Prior to installation, DONOR will provide proof to the CITY that the sand to be donated meets all relevant state standards established by the Department of Environmental Protection.
- d. DONOR agrees and understands that the CITY is scheduled for a beach renourishment for 2021 and is not able to accept the DONATION immediately. DONOR agrees that DONOR will execute the installation of the DONATION upon 60 days written notice from the CITY that the CITY can accept the DONATION. DONOR understands and agrees that this notice to proceed will not be provided until approximately a year after the Army Corps of Engineers completes the planned beach renourishment.

- e. DONOR agrees, as part of the DONATION, to pay for an independent inspector, selected by the CITY to oversee the project, including sand placement.
- f. DONOR understands and agrees that the CITY has expended significant and valuable time and resources in evaluating and processing DONOR's request to make the DONATION to the CITY.
- g. DONOR agrees to indemnify, defend, hold harmless, and releases the CITY OF HALLANDALE BEACH, its officers, employees, and officials its principals, successors, and assigns (collectively the "CITY") from and against all claims, actions, or causes of actions, losses, damages, liabilities, costs and expenses, including attorneys' and paralegals' fees, and fees of experts, threatened against, imposed from, and resulting from any and all claims, actions, or causes of actions, losses, including any claims by third parties, loss of life, bodily injury, and damage to any property, imposed on or incurred by the CITY in connection with any and all of the foregoing which arises, relates, or pertains, directly or indirectly, to the DONATION.
- h. The parties agree that this Agreement shall be interpreted and construed in accordance with and governed by the laws of the state of Florida. All parties agree and accept that jurisdiction of any controversies or legal problems arising out of this Agreement, and any action involving the enforcement or interpretation of any rights hereunder, shall be exclusively in the state courts of the Seventeenth Judicial Circuit in Broward CITY, Florida, and venue for litigation arising out of this Agreement shall be exclusively in such state courts, forsaking any other jurisdiction which either party may claim by virtue of its residency or other jurisdictional device.
- i. No modification, amendment, or alteration in the terms or conditions contained herein shall be effective unless contained in a written document prepared with the same or similar formality as this Agreement and executed by the CITY. This agreement may be signed in counterpart and multiple copies of this Agreement may be executed by all parties, each of which, bearing signatures of all parties, shall have the force and effect of an original document.

For IRS purposes, this agreement serves as written acknowledgment of your donation. The City of Hallandale Beach did not provide you any goods or services in consideration of this donation.
