RESOLUTION NO. 2021 -

A RESOLUTION OF THE MAYOR AND CITY COMMISSION OF THE CITY OF HALLANDALE BEACH, FLORIDA, AUTHORIZING THE RENEWAL OF 4:00 A.M. AND 6:00 A.M. NIGHTCLUB LICENSES FOR BUSINESSES LISTED IN EXHIBIT 1A FOR FISCAL YEAR 2021-2022; PROVIDING FOR CONFLICT, PROVIDING FOR SEVERABILITY; PROVIDING FOR AN EFFECTIVE DATE.

WHEREAS, pursuant to section 5-9 of the City's Code of Ordinances a person licensed under the provisions of the state beverage law may file an application with the City for a nightclub license to sell liquor, wine, and beer until the hours of 4:00 a.m. or 6:00 a.m.; and

WHEREAS, all nightclub licenses shall expire at 11:59 p.m. on September 30 of each year unless previously renewed by the City Commission; and

WHEREAS, pursuant to section 5-9 (d) of the City's Code of Ordinances, all current nightclub licenses shall be brought before the City Commission for consideration of renewal at the first regularly scheduled meeting in August; and

WHEREAS, for fiscal year 2021-2022 there are eight (8) establishments as listed in Exhibit 1A, seeking renewal of the nightclub license; and

WHEREAS, City staff has conducted inspections of the nightclub businesses and recommends the renewal of the eight (8) nightclub licenses as approved by the City Commission.

NOW, THEREFORE, BE IT RESOLVED BY THE MAYOR AND CITY COMMISSION OF THE CITY OF HALLANDALE BEACH, FLORIDA:

SECTION 1. The Mayor and the City Commission approve the renewal of the eight (8) nightclub licenses with conditions as listed in Exhibit 1A. Where corrections to code violations are required, correction of those violations must be made prior to October 1, 2021, or the license will be deemed expired.
