15	Manager is authorized to procure all supplies, materials, equipment and services pursuant to
16	competitive bids and formal contracts of other governmental units when the best interests of the
17	City would be served, subject to the requirement that any purchase in excess of \$50,000.00
18	requires City Commission approval; and

20	WHEREAS, the Police Department seeks to enter into a contract with Enterprise Leasing
21	Company of Florida, LLC, for the rental of automobiles, vans and sports utility vehicles required
22	to conduct patrol and undercover functions by piggybacking off the City of Coral Springs and
23	Enterprise Leasing Company of Florida, LLC (hereinafter referred to as Enterprise), Contract #17-
24	C-053; and
25	
26	WHEREAS, Police Department's (HBPD) Strategic Intelligence Unit (SIU) has an ongoing
27	need to rent vehicles for their day to day operations. The ability to maintain an active rotation of
28	unmarked, indistinguishable "police" vehicles for use in patrol and undercover operations makes
29	it less likely that officers are recognized, which is a key element to the success of such operations,
30	as well as for officer safety; and
31	
32	WHEREAS, the City Administration request authorization to piggy-back the City of Cora
33	Springs and Enterprise, Contract #17-C-053, as may be further amended, for rental cars, for an
34	amount not to exceed of sixty eight thousand nine hundred and eighty-two (\$68,982) dollars.
