14	WHEREAS, the Building Division for the City of Hallandale Beach faces
15	many challenges. In addition to software upgrade requirements which were
16	delayed for many years, the City has for many years faced a staffing shortage; and
17	
18	WHEREAS, the City of Hallandale Beach does not currently have enough
19	plans reviewers, inspectors, and other personnel in-house to handle the high
20	volume of permit applications that are received on a daily basis; and
21	
22	WHEREAS, in order to supplement the number of building division
23	reviewers and inspectors that we currently have working with us, the City currently
24	utilizes outside agreements with both CAP Government, and Calvin Giordano &
25	Associates (CGA), respectively for building services such as plans reviews and
26	inspections. However, due to the shortage of skilled building personnel working for
27	those companies, it has been very difficult for us to access those contracts fully;
28	and

30	WHEREAS, the County maintains an Environmental Protection and Growth
31	Management Department, which includes a Building Code Services Division
32	("BCSD") that conducts building official, plan review, permit inspections, code
33	enforcement, and other services relating to building. pursuant to the "unique
34	circumstances" and can provide services to the City on a non-guaranteed basis
35	pursuant to an interlocal agreement authorized pursuant to the unique

circumstances exception to competitive bidding requirements in Section 23-8 ofthe City Code; and

WHEREAS, the Mayor and City Commission find that that there are unique circumstances which warrant waiver of competitive bidding requirements and that it is in the best interest of the residents to authorize the proposed interlocal agreement with Broward County for Building inspection and other related services.
