24	Agreements relating to the provision of indirect and direct services by the City to the HBCRA, all		
25	in substantially the form attached hereto as Exhibit "A" and by this reference made a part hereof.

30	Section 2. Approval of Interlocal Agreements. The Board of Directors of the HBCRA

32	such non-material changes as may be requested by the City and/or the HBCRA and acceptable		
33	to the Executive Director and approved as to form and legality by the HBCRA Attorney.		
34	Section 3. Execution of Interlocal Agreements. The Executive Director is hereby		
35	authorized to execute the Interlocal Agreements.		
36	Section 4. Implementation of Interlocal Agreements. The Executive Director is hereby		
37	authorized to take all steps necessary and appropriate to implement the terms and conditions of		
38	the Interlocal Agreements including, but not limited to, the HBCRA making payments to the City.		

39	Section 5. <u>Effective Date</u> . This Resolution shall take effect immediately upon approval.
