FOR MAINTENANCE, REPAIRS AND OPERATIONS SUPPLIES, INDUSTRIAL EQUIPMENT AND TOOLS FOR AN AMOUNT NOT TO EXCEED ONE HUNDRED FIVE THOUSAND ONE HUNDRED (\$105,100.00) DOLLARS; AUTHORIZING THE CITY MANAGER TO EXECUTE ALL RELATED DOCUMENTS TO EFFECTUATE THE PURCHASE; AND PROVIDING AN EFFECTIVE DATE.

STAFF SUMMARY:

Summary:

Staff seeks City Commission approval to purchase various items through the contract with W.W. Grainger utilizing Sourcewell contract solutions.

Background:

The Procurement Department facilitates the purchase of specific commodities that the City procures annually through cooperative purchasing. As a member of Sourcewell, the City can participate and utilize competitively solicited contracts to obtain the best goods/services and pricing available in the market. A self-sustaining government organization, Sourcewell has over 40 years of dedicated service helping government, education and non-profit agencies operate efficiently through a variety of contract solutions. Contract purchasing solutions are competitively solicited nationwide, offering over 400 awarded contracts.

The City wishes to purchase various items through the contract with W.W. Grainger as described below for \$105,100.

The contract term for W.W. Grainger Contract/RFP # 121218 is from January 25, 2019 through January 25, 2023.

Some of the purchases made by Departments utilizing this contract include but are not limited to, electrical supplies, mechanical equipment, hand soap, pumps, incandescent light bulbs, and mats of all kinds. These items can be purchased from the store located in Pompano Beach and/or online.
