L8	competitive bids of other governmental units, when the best interests of the City would be
L9	served, subject to the requirement that purchases in excess of \$50,000 require City

23	exceed one hundred nineteen thousand nine hundred (\$119,900.00) dollars for supplies
24	from Home Depot Pro utilizing Omnia Partners/US Communities Contract RFP # 16154;

27	WHEREAS, authorized City staff received a log in to utilize the Home Depot Pro
28	contracted pricing and make purchases on-line. Some of the purchases made by City staff
29	are paint, hardware, toolboxes, small plumbing materials, wood, electrical supplies, and
30	other related items, and other related items at the following Home Depot locations: 1951
31	South State Road 7, West Park, FL 33023 and 3401 Oakwood Blvd, Hollywood, FL 33020.

33	WHEREAS, the Mayor and City Commission find that it is in the best interest of
34	the City of Hallandale Beach to authorize the utilization of the requested contract.

36	NOW, THEREFORE, BE IT RESOLVED BY THE MAYOR AND THE CITY

46	documents to effectuate the purchase.
