**A RESOLUTION OF THE MAYOR AND CITY COMMISSION OF THE CITY OF HALLANDALE BEACH, FLORIDA, AUTHORIZING THE UTILIZATION OF THE GSA CONTRACT 47QTCA18D00JG AND 47QTCA19D00MV AND THE STATE OF FLORIDA DEPARTMENT OF NWN CORP. SUNCOM COMMUNICATIONS SERVICES CONTRACT DMS-17/18-004D FOR THE PURCHASE OF LANDLINE(S), INTERNET, CELLULAR AND WIRELESS COMMUNICATION FOR ALL CITY DEPARTMENTS FOR A TERM OF THREE (3) YEARS FOR AN ANNUAL FISCAL AMOUNT NOT TO EXCEED ONE HUNDRED EIGHTY THOUSAND (\$180,000) DOLLARS; AUTHORIZING THE CITY MANAGER TO EXECUTE ALL RELATED DOCUMENTS TO EFFECTUATE THE PURCHASES; AND PROVIDING AN EFFECTIVE DATE.**

23           **WHEREAS**, pursuant to Chapter 23, Section 23-8 (6), Exception to Bid  
24 Requirements, and Section 23-9 Cooperative Purchase, the City Manager is authorized  
25 to procure supplies, materials, equipment and services from contracts of other  
26 governmental units, when the best interests of the City would be served subject to the  
27 requirement that any purchase in excess of \$50,000 requires City Commission approval;  
28 and

30           **WHEREAS**, the City of Hallandale Beach is eligible to utilize negotiated and  
31 approved State of Florida purchasing contracts, specifically, the Florida Department of  
32 Management Services contract and the U.S. General Service Administration's  
33 Cooperative Contract, and contracts of the U.S. Communities Government Purchasing  
34 Alliance; and

36           **WHEREAS**, the use of the negotiated contracts allows state and local  
37 governments to use GSA schedules for select purchases under multiple authorized  
38 programs, and the utilization of GSA schedules to obtain equipment and services, thereby  
39 saving taxpayers money; and

41           **WHEREAS**, the utilization of GSA Contract 47QTCA18D00JG and  
42 47QTCA19D00MV and The State of Florida Department of NWN Corp. Suncom

43 Communications Services Contract DMS-17/18-004D authorizes the purchase of  
44 landline(s), internet, cellular and wireless communication(s); and

46 **WHEREAS**, the City Administration has identified a need to utilize the GSA  
47 Contract 47QTCA18D00JG and 47QTCA19D00MV and The State of Florida Department  
48 of NWN Corp. Suncom Communications Services Contract DMS-17/18-004D to purchase  
49 from AT&T landline(s), internet, cellular and wireless communication(s) for all City  
50 Departments for a term of three (3) years for an annual fiscal amount not to exceed  
51 \$180,000 dollars.

53 **NOW, THEREFORE, BE IT RESOLVED BY THE MAYOR AND THE CITY**  
54 **COMMISSION OF THE CITY OF HALLANDALE BEACH, FLORIDA:**

56 **SECTION 1.** The foregoing "Whereas" clauses are incorporated herein.

58 **SECTION 2. City Manager Authorization.** The Mayor and City Commission  
59 hereby authorize the City Manager to utilize the GSA Contract 47QTCA18D00JG and  
60 47QTCA19D00MV and The State of Florida Department of NWN Corp. Suncom  
61 Communications Services Contract DMS-17/18-004D to purchase from AT&T landline(s),  
62 internet, cellular and wireless communication(s) for all City Departments for a term of three  
63 (3) years for an annual fiscal amount not to exceed one hundred and eighty thousand  
64 (\$180,000) dollars; further authorizing the City Manager to execute all related documents  
65 to effectuate the purchases.

67 **SECTION 3. Effective Date.** This Resolution shall take effect  
68 immediately upon its passage and adoption.
