**SHORT TITLE:**

**A RESOLUTION OF THE MAYOR AND CITY COMMISSION OF THE CITY OF HALLANDALE BEACH, FLORIDA, AUTHORIZING USE OF CONTINUING SERVICE AGREEMENT TO RETAIN THE SERVICES OF THE CORRADINO GROUP, INC. TO DESIGN THE LIFT STATION #10, #11 AND #15 REPLACEMENTS AND IMPROVEMENTS PROJECT IN AN AMOUNT NOT-TO-EXCEED FOUR HUNDRED EIGHTY-SEVEN THOUSAND, SIX HUNDRED SIXTY-TWO DOLLARS (\$487,662); AND PROVIDING AN EFFECTIVE DATE.**

## STAFF SUMMARY:

### **Summary:**

This agenda item seeks City Commission approval to retain the services of The Corradino Group to design Lift Stations 10, 11, and 15 Replacements and Improvements, in accordance with RFP #2018-2019-012 – Continuing Professional Architectural and Engineering Services, for an amount not-to-exceed \$487,662. The above listed consultant will be providing services based on the Civil Engineering Services discipline. The preliminary opinion of probable cost for this project is \$2,683,815. (Exhibit 2)

### **Background:**

On August 5, 2020, the City Commission approved Resolution No. 2020-054 authorizing continuing service agreements to be awarded in accordance with the Consultant Competitive Negotiation Act (CCNA). (Exhibit 3)

The Public Works team continues to reassess the City's current infrastructure. Based on findings during past and recent emergency response to infrastructure failure, we believe there is a need to immediately initiate as many projects for design as we can to engage in an effective rehabilitation strategy for the City.

### **Current Situation**

The Lift Stations 10, 11 and 15 Replacements and Improvements were identified in the Wastewater Masterplan. Currently, the City is undertaking wastewater system upgrades to address the need for capacity related, renewal and replacement (R&R), and regulatory driven improvements. The City will replace Sewage the following Lift Stations:

<b>Lift Station No.</b>	<b>Location</b>
Lift Station No. 10	298 Sunset East Drive
Lift Station No. 11	430 Holiday Drive
Lift Station No. 15	490 Sunset West Drive

The Corradino Group has submitted the attached cost proposal to perform the work described above for an amount not-to-exceed \$487,662 (Exhibit 2).

### **Why Action is Necessary:**

Pursuant to Chapter 23, Section 23-4, Competitive Bidding Required, all purchases of and contracts for equipment, supplies and contractual services, when the estimated cost shall exceed \$50,000.00 shall be based on competitive bids. Furthermore, pursuant to Chapter 23, Section 23-6, Award of Contract, the City Manager, shall have the authority to recommend to the City Commission award of contracts. Chapter 23, Section 23-8 (7) Continuing Services Agreements. Individual purchases for professional services not exceeding \$75,000 made pursuant to continuing services agreements resulting from a publicly solicited Request for Proposals may be approved by the City Manager.

**Cost Benefit:**

Initiating the design of multiple projects now will allow for a more effective use of bond proceeds for construction upon their disbursement. Additionally, we know many grant opportunities require an applying municipality to have “shovel ready” projects for funding consideration. The City has missed out on previous opportunities to apply for grants because of not having projects at this stage of readiness. The Public Works team believes that changing this dynamic, applying for and potentially receiving grant funds, will expedite our ability to rehabilitate our infrastructure with the additional funding.

**PROPOSED ACTION:**

The City Commission approve the attached resolution authorizing to retain the services of The Corradino Group to design Lift Stations 10, 11 and 15 Replacements and Improvements, in accordance with RFP #2018-2019-012 – Continuing Professional Architectural and Engineering Services, for an amount not-to-exceed \$487,662; and authorizing the City Manager to execute the awarded contract.
