17	released a Request for Proposal (RFP) #FY 2016-2017-010, State Lobbyist Services on July 5,	
18	2017 to retain the services of a State Lobbyist Firm to assist with a variety of issues affecting the	
19	City and its residents at a State level; and	
20	WHEREAS, the City Commission, in Resolution 2017-104 authorized the award of a	
21	contract including two option one-year renewals subject to City Commission approval; and	
22		
23	WHEREAS, the City approved the extension of the second one-year renewal in resolution	
24	2020-105 for the 2020 Legislation Services	
25		
26	WHEREAS, the City declared its emergency order on Marcy 9, 2020 in Executive Order	
27	20-52, as a result of COVID19 waiving procurement formalities and requirements. The City	
28	anticipates the release of the new RFP for state lobbyist services in September 2020, which will	
29	not allow sufficient time to fully execute a new agreement prior to October 12, 2020, which	
30	terminates the existing agreement; and

32	WHEREAS, City Administration is requesting to continue with Ballard Partners on a month	
33	to month basis for the same cost of the current state lobbyist services of \$5,000 per month not to	
34	exceed \$40,000 until new RFP is awarded and executed; and
