10	residents and visitors of Hallandale Beach for over twenty (20) years; and

12	WHEREAS, on February 19, 2020, the City Commission voted to award RFP #	
13	FY2018-2019-007 for Minibus Services to LIMOUSINES OF SOUTH FLORIDA INC. and	
14	authorized the City Manager to negotiate a contract that will be brought back for City	
15	Commission approval; and	
16		
17	WHEREAS, in March of 2020, the City declared a state of emergency due to the	
18	global pandemic of COVID-19. Events related to the pandemic drastically affected globally	
19	businesses and economies. Rapidly shifting dynamics resulted in an inability for the	
20	awarded minibus shuttle Contractor for RFP FY 2018-2019-007 to reach an agreement to	
21	proceed with the award as solicited by the City and as proposed by the Contractor; and	
22		
23	WHEREAS, Section 23-12 of the City's Code permits the City Commission to	
24	authorize the City Manager to reject all bids and re-advertise a new solicitation; and	
25		
26	WHEREAS, City Administration has identified an alternative option for providing	
27	the services and recommends that the solicitation be reissued for operation and	
28	maintenance of the minibus service with propane buses to be obtained by City from	
29	County, and a future transition into an all-electric vehicle fleet.; and	
30		
31	WHEREAS, the Mayor and City Commission find it is in the best interests of the	
32	residents of the City to reject all proposals and issue a new solicitation based on the City'	
33	current needs and situation.
