**RESOLUTION NO. 2014 - 45**

**A RESOLUTION OF THE MAYOR AND CITY COMMISSION  
OF THE CITY OF HALLANDALE BEACH, FLORIDA  
AWARDING RFP # FY2013-2014-002 TO LIMOUSINES OF  
SOUTH FLORIDA, INC., FOR OPERATING THE  
COMMUNITY BUS SERVICE; AUTHORIZING THE CITY  
MANAGER TO NEGOTIATE AND EXECUTE AN  
AGREEMENT AND ALL RELATED DOCUMENTS WITH  
LIMOUSINES OF SOUTH FLORIDA, INC., IN  
SUBSTANTIALLY THE SAME FORM AS ATTACHED AS  
EXHIBIT A; AND PROVIDING FOR AN EFFECTIVE DATE.**

**WHEREAS**, the City began offering the community transportation service over fifteen  
years ago; and

**WHEREAS**, over the years the City has consistently gauged the public's opinion in  
order to improve this service; and

**WHEREAS**, the community values this service and the ridership has steadily increased  
from 91,700 in 2009 to 283,338 in 2013 – a 90.50% increase in 4 years; and

**WHEREAS**, City has been utilizing (piggybacking) other governmental entities'  
contract to secure the community bus service and utilizing the service of the same vendor for  
the past 10 years; and

**WHEREAS**, in an effort to gauge the market and assure that the City is not missing  
out on any opportunities that may now exist in the industry, the City has deemed it necessary  
to perform due diligence by releasing its own solicitation; and

**WHEREAS**, City administration reviewed the bid proposals and completed a summary  
rating sheet, and these ratings were based on firms qualifications and experience, project  
team experience, examples of past proposals, past performance references, financial  
resources, cost, crisis management plan, and the City's local vendor preference; and

**WHEREAS**, upon completion of City administration's review, Limousines of South  
Florida, Inc., received the higher score and was determined to be the preferred finalist vendor  
by the selection committee; and

42       **WHEREAS**, City administration is of the belief that it is in the best interest of the City  
43 of Hallandale Beach and it's residents that RFP #FY2013-2014-002 for Community Bus  
44 Services be awarded to Limousines of South Florida, Inc. as the responsible, responsive  
45 bidder, and that the City Manager be authorized to negotiate and execute an agreement and  
46 all related documents, in substantially the same form as attached as Exhibit 4.

48       **NOW, THEREFORE, BE IT RESOLVED BY THE MAYOR AND CITY**  
49 **COMMISSION OF THE CITY OF HALLANDALE BEACH, FLORIDA:**

51       **SECTION 1. Award of Bid.** The Mayor and City Commission hereby award FY2013-  
52 2014-002, Community Bus Services to Limousines of South Florida, Inc., as the responsive  
53 bidder.

54       **SECTION 2. City Manager Authorization.** The Mayor and City Commission hereby  
55 authorize the City Manager to negotiate and execute an agreement and all related documents  
56 with Limousines of South Florida, Inc., in substantially the same form as attached as Exhibit  
57 A.

58       **SECTION 3. Effective Date.** This Resolution shall take effect immediately upon its  
59 passage and adoption.


