## **SHORT TITLE:**

AN ORDINANCE OF THE MAYOR AND CITY COMMISSION OF THE CITY OF HALLANDALE BEACH, FLORIDA, CREATING CHAPTER 6, DIVISION 3, "TRADE OF FUR PRODUCTS," OF THE HALLANDALE BEACH CODE PROHIBITING THE SALE, OFFER FOR SALE, DISPLAY FOR SALE, TRADE, OR OTHER DISTRIBUTION FOR MONETARY OR NONMONETARY CONSIDERATION OF FUR PRODUCTS; PROVIDING **EXCEPTIONS: PROVIDING DEFINITIONS: PROVIDING APPLICABILITY: PROVIDING PENALTIES: PROVIDING FOR** CONFLICTS; PROVIDING FOR SEVERABILITY; PROVIDING FOR CODIFICATION; PROVIDING FOR AN EFFECTIVE DATE.

## **STAFF SUMMARY:**

The proposed ordinance would ban the sale of furs in the City.

- COVID-19: Since April 2020, mink on more than 430 fur farms across Europe and North America including four US states have tested positive for SARS-CoV-2, the virus that causes COVID-19. Farmed mink are the only species known to transmit COVID-19 to humans, and the mutations might reduce the efficacy of vaccines. Nearly 20 million mink were killed to protect public health. Foxes and raccoon dogs have also tested positive for coronaviruses. Fur farms are reservoirs for infectious diseases and possibly the next pandemic.

- Environment: On fur factory farms, waste runoff from animal pollutes the soil and waterways, and the tanning and dying process uses toxic chemicals, such as chromium and formaldehyde, to prevent the skin from decaying. Luckily, warm and fashion alternatives are readily available.
