 13	Maintenance and Compensation Agreement with the Florida Department of
14	Transportation (FDOT) pursuant to which FDOT pays the City to maintain standard
15	lights (the "Standard Lighting Maintenance Agreement"); and
16	WHEREAS, the FDOT is planning an improvement project (FM# 441582-1-
17	52-01) that will span from portions of the City of Hallandale Beach into the City of
18	Hollywood, and the FDOT has asked the City of Hallandale Beach to maintain
19	certain non-standard or decorative lighting elements constructed under this project
20	(the "Project"); and
21	WHEREAS, in order to compensate the City of Hallandale Beach for
22	maintenance on non-standard lighting elements that will be included in the Project,
23	the FDOT has proposed that the City enter into a District Four Maintenance
24	Memorandum of Agreement (the "Non-Standard Lighting Maintenance MOA"); and
25	WHEREAS, the FDOT requires the City Commission's approval for the City
26	to enter in the Non-Standard Lighting Maintenance MOA with it; and
27	WHEREAS, under the Standard Lighting Maintenance Agreement, the City
28	received compensation per luminaire of \$300.10 for fiscal year FY 2020-2021, which
29	compensation the FDOT has been increasing by three percent (3%) annually; and
30	WHEREAS, the proposed agreement covering the new lights will not affect
31	the existing compensation agreement; and

32	WHEREAS, Staff believes that it is in the public interest to enter into the Non-
33	Standard Lighting Maintenance MOA and recommends that the Mayor and City
34	Commission authorize the City Manager to execute it and any relating documents.
