25 26 27	WHEREAS, funding allocation is non-competitive, however, cities must still apply to receive funding; and
28	WHEREAS, the City of Hallandale Beach applies for JAG funds annually. Per the
29	Program requirements, public notice must be made for acceptance of the grant. To fulfill this
30	requirement staff advertised via the Hallandale Beach Police Department's website to gather
31	information from the public; and
32	WILEDEAC the program also requires all amplications he approved by the City

34 35	Commission and if so approved, JAG21 funding will become available during fiscal year 2021-2022; and
