This First Amendment to the Contract 20-55 Sodium Hypochlorite is entered into on July 7, 2021, by and between the Bay County Board of County Commissioners, at 840 West 11th St., Panama City, Florida 32401 ("County"), and Odyssey Manufacturing Company, located at 1484 Massaro Blvd., Tampa, FL 33619 ("Contractor").

1. Intent

The County and Contractor entered into a Contract on August 4, 2020. This amendment is necessary to allow for a one-year renewal with a five percent (5%) price increase.

2. Amendments

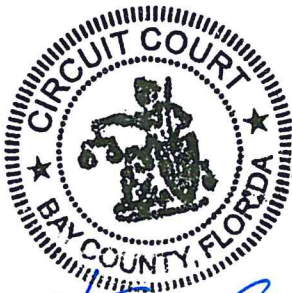
- a) The term of the contract is hereby renewed for one additional one-year term effective October 1, 2021 through September 30, 2022.
- b) The contract price is hereby increased five percent (5%) effective October 1, 2021.

FINANCIAL IMPACT SUMMARY STATEMENT:

The annual contract costs are budgeted every year. This will be placed in the upcoming FY 22 budget.

BACKGROUND:

On August 4, 2020 the Board approved a contract with Odyssey Manufacturing Company for Sodium Hypochlorite. The current contract price is \$0.795 per gallon. Odyssey Manufacturing Co. has requested an increase of five percent (5%) resulting in an annual renewal contract price of \$0.835 per gallon. The First Amendment is attached as **Exhibit 1**. Price increases are allowable by the contract and were substantiated utilizing the Producer Price Index (PPI).
