SHORT TITLE:

A RESOLUTION OF THE MAYOR AND CITY COMMISSION OF THE CITY OF HALLANDALE BEACH, FLORIDA, UTILIZING CODE SECTION 23-8(5) UNIQUE CIRCUMSTANCES TO AUTHORIZE EXECUTION OF AMENDMENT NO. 1 TO AGREEMENT WITH UNITED STATES SERVICE INDUSTRIES, INC. FOR BID FY 2017-2018-009 CUSTODIAN SERVICES CITYWIDE IN ORDER TO EXTEND THE AGREEMENT ON A MONTH TO MONTH BASIS; REPEALING RESOLUTION NUMBER 21-139; AUTHORIZING THE CITY MANAGER TO SIGN ALL RELATED DOCUMENTS; AND PROVIDING AN EFFECTIVE DATE.

STAFF SUMMARY:

Summary:

This agenda item seeks to revise the dollar figure in Resolution No. 21-139 adopted on 10/20/2021 for the Custodial Contract Month-to-Month term extension with United States Services Industries, Inc. (USSI).

Background:

On June 6, 2018, City Commission approved Resolution No. 2018-045 awarding a three-year contract to USSI. The contract expires on July 30, 2021. The current contract does not provide for an extension beyond the expiration date.

On August 24, 2021, the City issued ITB # FY 2020-2021-008 Janitorial Services for City Facilities.

On September 2, 2021, the City Manager approved extending the contract on a month-to-month basis for an amount not to exceed \$50,000. This extension will expire mid December 2021. On

October 20, 2021, City Commission approved Resolution No. 2021-139 (Exhibit 2) extending the term of the month-to-month Custodial Contract with USSI. However, there was a discrepancy between the dollar figure in the cover memo and the resolution. The instant item will repeal the previous resolution and replace with the correct dollar figure.

Current Situation:

The current deadline of 9/27/2021 to respond to the ITB will have to be extended. This extension is needed because, based on the number of companies that have signed up to be part of the mandatory site visits and COVID19 protocols, the Procurement Department must hold the site visits during Fridays when City buildings are unoccupied. Per the Risk Manager no more than 10 total staff and firms at one time are allowed to be present to do the site visits. At these time, 15 different companies have signed up for the site visits. Based on this new timeline, the current month-to-month agreement will expire prior to the City Commission awarding a new custodial service contract.

The City received confirmation that USSI will honor the terms and conditions including pricing of the existing contract on a month-to-month basis beyond the contract's expiration date of July 31, 2021. The total contract amount for the past 3-year term is \$681,813. To date the City has encumbered \$454,520.21, which leaves a balance of \$227,292.79. The monthly expenditure is anticipated to be \$11,191.

To maintain a sanitary and sanitized environment in City facilities, it is in the City's best interest to have no interruption in custodial service. This need is even more imperative as we are still emerging from the COVID-19 pandemic. Staff recommends the City Commission consider these unique circumstances and approve an extension to the month-to-month contract beyond the City Manager's threshold.

Why Action is Necessary:

Revise the dollar figure in Resolution No. 21-139 adopted on 10/20/2021 for the Custodial Contract Month-to-Month term extension with USSI.

Cost Benefit:

There will be no price increase. The current vendor will continue providing service and agrees to honor the current price structure beyond the contract's expiration date of July 31, 2021.

PROPOSED ACTION:

City Commission to approve a resolution with the revised the dollar figure for the Custodial Contract Month-to-Month term extension with United States Services Industries, Inc. (USSI).
