RESOLUTION NO. 2021 -

A RESOLUTION OF THE MAYOR AND CITY COMMISSION OF THE CITY OF HALLANDALE BEACH, FLORIDA, AUTHORIZING THE CITY MANAGER TO UTILIZE THE BAY COUNTY, FLORIDA, CONTRACT PURSUANT TO ITB NO. 20-55 TO PURCHASE LIQUID SODIUM HYPOCHLORITE FROM ODYSSEY MANUFACTURING COMPANY IN AN AMOUNT NOT TO EXCEED NINETY THOUSAND DOLLARS (\$90,000); AND PROVIDING FOR AN EFFECTIVE DATE.

WHEREAS, pursuant to Section 23-9 of the City of Hallandale Beach (“City”) Code, the City Manager shall have the authority to join with other units of government in cooperative purchasing plans or to purchase pursuant to formal written contracts or competitive bids of other governmental units, when the best interests of the City would be served, subject to the requirement that purchases in excess of \$50,000 require City Commission approval; and

WHEREAS, Bay County, Florida awarded Bid #20-55 for the purchase of Liquid Sodium Hypochlorite to Odyssey Manufacturing Company; and

WHEREAS, the City Administration projects that the expenditure for Liquid Sodium Hypochlorite for Fiscal Year 2021-2022 will not exceed Ninety Thousand Dollars (\$90,000); and

WHEREAS, the Mayor and City Commission have determined that it is in the best interest of the residents of the City of Hallandale Beach to utilize the Bay County Agreement to purchase Liquid Sodium Hypochlorite for Fiscal Year 2021-2022 in an amount Not to Exceed Ninety Thousand Dollars (\$90,000), and to authorize the City Manager to execute all related documents.

NOW, THEREFORE, BE IT RESOLVED BY THE MAYOR AND CITY COMMISSION OF THE CITY OF HALLANDALE BEACH, FLORIDA:

SECTION 1. City Manager Authorization. The Mayor and City Commission hereby authorize the City Manager to utilize the Bay County Agreement to purchase Liquid Sodium Hypochlorite for Fiscal Year 2021-2022 in an amount Not to
