16 17	WHEREAS, in October 11, 2019 the Mayor and City Commission approved the
18	Interlocal Agreement (ILA) with Broward County for the partial funding of the City's Community
19	Bus Service via City Resolution No 2019-096. The term of the agreement was retroactive to
20	October 1, 2019, until September 30, 2022 and it provided for a reimbursement rate to the
21	City of forty-six dollars and ninety-four cents (\$46.94); and
22	
23	WHEREAS, the proposed First Amendment to the Interlocal Agreement between the
24	City and Broward County (County) for Community Shuttle Services, would increase the
25	reimbursement rate to fifty-one dollars and ninety-four cents per hour \$ 51.94. to account for
26	a reduced schedule and the higher cost of maintaining an older fleet of vehicles; and
27	
28	WHEREAS the Mayor and City Commission find that approval of the First Amendment
29	to the Interlocal Agreement between the City and Broward County (County) for Community
30	Shuttle Services is in the best interest of the residents of the City; and
31	
32	NOW, THEREFORE, BE IT RESOLVED BY THE MAYOR AND CITY COMMISSION
33	OF THE CITY OF HALLANDALE BEACH, FLORIDA:

35	SECTION 1. That the foregoing "Whereas" clauses are incorporated herein

37	SECTION 2. The Mayor and City Commission hereby approve the First Amendment
38	to the Interlocal Agreement between the City and Broward County for Community Shuttle

SECTION 3. That this Resolution shall be effective immediately upon its adoption.

Services and authorize the City Manager to execute the proposed agreement.
