5. BOARD/COMMITTEE BUSINESS

a. Old Business

GO Bond Project Updates
 Director Schanz provided thorough updates on the Sunrise Park (plans and pricing in process), Historic Village (plans in process), and Chaves Lakes (environmental focus) Projects.

II) COVID-19 Updates Parks Reopening
Director Schanz reported that the OB Johnson Gyms and Computer Lab
reopened for public use on September 1st. The afterschool program
reopened on September 7th.
She also reminded the board that masks and temperature checks are
required in all City facilities.

Member Wright requested on the PAL program. He was encouraged to discuss with the PAL Coordinator, Jonathan Carrillo.

Member Wright also brought up concerns regarding charging resident youth to use the open gym at OB Johnson. Director Schanz will bring a report back to the next meeting to see if it is feasible to increase Adult usage fees to reduce or eliminate Youth usage fees.

Member Southwick requested an update on the Tennis Center Marketing Plan. She said it is a beautiful facility but there is no one there. Director Schanz will request an updated plan from the Operator, All Florida Tennis, Inc. and invite Mr. Smatt to the next meeting.

Member Plummer informed the board that this will be his last meeting as he has moved out of the City. The board thanked him for his service and wished him well.

An election was held to fill his vacated Vice Chair position on the board. A motion was made by Member Plummer to nominate Member Wright. The motion was seconded by Member Garson. The motion passed unanimously.
