12	WHEREAS, on October 11, 2019, the Mayor and City Commission approved
13	the Interlocal Agreement (ILA) with Broward County for the partial funding of the City's
14	Community Bus Service via City Resolution No 2019-096. The agreement provided
15	for a reimbursement rate to the City of forty-six dollars and ninety-four cents (\$46.94)
16	and
17	
18	WHEREAS, on January 25, 2021, the parties executed the First Amendment
19	to the Interlocal Agreement between the City and Broward County (County) for
20	Community Shuttle Services, which increased the reimbursement rate to fifty-one
21	dollars and ninety-four cents per hour (\$51.94) to account for a reduced schedule and
22	the higher cost of maintaining an older fleet of vehicles; and
23	
24	WHEREAS, the proposed Second Amendment to the Interlocal Agreement
25	between the City and County for Community Shuttle Services amends the vehicle list
26	to reflect the new vehicles owned by the County that will leased by the City for ter
27	dollars (\$10) each per year pursuant to Section 3.1 of the ILA, until the electric vehicle
28	fleet is manufactured and delivered; and
29	
30	WHEREAS the Mayor and City Commission find that approval of the Second
31	Amendment to the Interlocal Agreement between the City and Broward County
32	(County) for Community Shuttle Services is in the best interest of the residents of the
33	City; and

35	NOW, THEREFORE, BE IT RESOLVED BY THE MAYOR AND CITY
36	COMMISSION OF THE CITY OF HALLANDALE BEACH, FLORIDA:
