4 A RESOLUTION OF THE MAYOR AND CITY COMMISSION OF THE
5 CITY OF HALLANDALE BEACH, FLORIDA AUTHORIZING PURCHASE
6 FROM THE PARTS HOUSE FOR AUTOMOTIVE PARTS FOR AN
7 AMOUNT NOT TO EXCEED EIGHTY THOUSAND DOLLARS (\$80,000)
8 UTILIZING TERMS OF SEMINOLE COUNTY, FLORIDA CONTRACT;
9 AND PROVIDING AN EFFECTIVE DATE.

11 WHEREAS, pursuant to Section 23-8(6) Bids and Contracts from other entities,
12 the City Manager is authorized to procure all supplies, materials, equipment and services
13 pursuant to competitive bids and formal contracts of other governmental units when the
14 best interests of the City would be served, subject to the requirement that any purchase
15 in excess of \$50,000.00 requires City Commission approval; and

17 WHEREAS, staff recommends utilizing the October of 2017 contract, renewed until
18 November 30, 2022, between Seminole County and The Parts House competitively
19 solicited via RFP-60291-17/BJC; and

21 WHEREAS, by utilizing another entity's contract, staff seeks to find better prices
22 for automotive parts by having a wider selection of vendors to buy from whom to buy; and

24 WHEREAS, Staff seeks the City Commission's authorization of the City to purchase
25 automotive parts and supplies from The Parts House, as needed, utilizing the Seminole
26 County Contract for a total amount not-to-exceed amount for Fiscal Year 2021-2022 of
27 eighty thousand (\$80,000) dollars and authorize the City Manager to execute all related
28 documents to effectuate the purchase of automotive parts and supplies for FY 2021-2022.

30 NOW, THEREFORE, BE IT RESOLVED BY THE MAYOR AND THE CITY
31 COMMISSION OF THE CITY OF HALLANDALE BEACH, FLORIDA:

33 SECTION 1. The foregoing "Whereas" clauses are incorporated herein.

35 SECTION 2. The Mayor and City Commission hereby authorize the City to
36 purchase automotive parts and supplies from The Parts House, as needed, utilizing the

37 Seminole County Contract for a total amount not-to-exceed amount for Fiscal Year 2021-
38 2022 of eighty thousand (\$80,000) dollars and authorize the City Manager to execute all
39 related documents to effectuate the purchase of automotive parts and supplies for FY
40 2021-2022.
