RESOLUTION NO. 2024-137

**A RESOLUTION OF THE MAYOR AND CITY COMMISSION OF
THE CITY OF HALLANDALE BEACH, FLORIDA, APPOINTING
COMMISSION MEMBERS AS CITY REPRESENTATIVES TO
THE BROWARD LEAGUE OF CITIES, FLORIDA LEAGUE OF
CITIES, AND THE NATIONAL LEAGUE OF CITIES FOR THE
2025-2026 TERM; AND PROVIDING AN EFFECTIVE DATE.**

11 **WHEREAS**, annually, the Mayor and City Commission appoints Officers/Directors,

13 League of Cities, Florida League of Cities, and National League of Cities; and

15 **WHEREAS**, the Broward League of Cities' by-laws require that the Mayor and City
16 Commission appoint a Director, an Alternate, and a Second Alternate to the Board of Directors;

19 **WHEREAS**, the Florida League of Cities' by-laws require the appointment of a voting
20 delegate and an alternate to attend and vote at the annual business session; and

22 **WHEREAS**, the National League of Cities' by-laws require the appointment of a voting
23 delegate, and one (1) alternate, (if desired) to attend and vote at the annual business meeting.

25 **NOW, THEREFORE, BE IT RESOLVED BY THE MAYOR AND THE CITY**
26 **COMMISSION OF THE CITY OF HALLANDALE BEACH, FLORIDA:**

28 **SECTION 1. Appointments to the League of Cities.** The Mayor and City Commission
29 hereby makes the following appointments for the 2025-2026 cycle:
