TO DESIGN THE NE 7TH AVENUE FORCE MAIN IMPROVEMENTS PROJECT IN AN AMOUNT NOT TO EXCEED FOUR HUNDRED TWELVE THOUSAND, ONE HUNDRED TEN DOLLARS (\$412,110); AUTHORIZING THE CITY MANAGER TO SIGN ALL RELATED DOCUMENTS; AND PROVIDING AN EFFECTIVE DATE.

WHEREAS, on August 5, 2020, the City Commission of Hallandale Beach adopted Resolution 2020-054 authorizing continuing service agreements solicited through RFP #2018-2019-012 — Continuing Professional Architectural and Engineering Services pursuant to Section 287.055, F.S., the Consultants Competitive Negotiation Act (CCNA); and

WHEREAS, effective December 15, 2020, the City of Hallandale Beach entered into its CCNA agreement with one of the selected design professional firms, Craig A. Smith & Associates, Inc. (Consultant), which permits the parties to execute Work Authorizations for specific City projects from time to time that do not exceed current CCNA statutory threshold amounts; and

WHEREAS, the NE 7th Avenue Force Main Improvements Project has been identified in the City's Wastewater Masterplan; and

WHEREAS, the purpose of this project is the construction of a new 20-inch diameter sanitary force main along NE 7th Street due South and East of the Hollywood Dog Track in Hallandale Beach; and

WHEREAS, the proposed construction of the 20-inch force main will begin at the intersection of NE 7th Street and the West side Dixie Highway, installed
