18	WHEREAS, pursuant to Chapter 23, Section 23-4, City of Hallandale Beach Code of
19	Ordinances, purchases of and contracts for equipment, supplies, and contractual services,
20	when the estimated cost shall exceed \$50,000, except as specifically provided in that
21	section, shall be based, wherever possible, on competitive bids Code of Ordinances, Code
22	of Ordinances, Code of Ordinances; and

24	WHEREAS, due to ongoing challenges in fully staffing the landscape division to

on to ensure continuity of operations, the City released Bid # FY 2022-2023-021 - Citywide 25 26 Grounds Maintenance on September 21, 2023 for the supply of all labor, equipment, tools, 27 and materials from qualified and certified contractors to maintain designated roadway 28 medians, swales, gateways, lots, and other facilities within the City limits; and

30 WHEREAS, Parks, Recreation, and Open Spaces Department recommends that the Mayor and City Commission find it in the public interest to award Bid # FY 2022-2023-021 -31 Citywide Grounds Maintenance to the lowest responsible bidder, Green Dreams Paradise 32 33 Corporation, in the amount of Five Hundred and One Thousand, One Hundred and Eighty-One Dollars (\$501,181) annually; 34

WHEREAS, historically the City has had high turnover with grounds maintenance 36 37 bidders underbidding and abandoning their agreements, staff recommends that the City Commission authorize an agreement with the second lowest responsible bidder, A Perfect Edge, Inc., in the amount of Five Hundred, Twenty-One Thousand, Six Hundred and Sixty-Seven Dollars (\$521,667) annually, to be executed and commenced within a year of the approval of this resolution should Green Dreams Paradise Corp. be terminated from or abandon their agreement, and authorize the City Manager to execute all relating documents; and

45 **WHEREAS**, purchase orders issued under the secondary bid award will be issued 46 only when the primary contractor voluntarily defers the work or is unable to perform, or 47 when the City determines that the primary contractor's maximum service capacity has been 48 reached and additional service capacity is still needed by the city to meet City's service 49 timeframes.

The Mayor and City Commission hereby award Bid # FY 2022-2023-56 021 – Citywide Grounds Maintenance to the lowest responsible bidder, Green Dreams 57 58 Paradise Corporation, in the amount of Five Hundred and One Thousand, One Hundred 59 and Eighty-One Dollars (\$501,181) annually, further authorize an agreement with the second lowest responsible bidder, A Perfect Edge, Inc., in the amount of Five Hundred, 60 Twenty-One Thousand, Six Hundred and Sixty-Seven Dollars (\$521,667) annually, in 61 62 accordance with their bid terms, to be executed and commenced within a year of the approval of this resolution should Green Dreams Paradise Corp. be terminated from or 63 abandon their agreement, and authorize the City Manager to execute all relating 64 65 documents.
