24	WHEREAS, applicant, Cirque Du Soleil America Newco, Inc., has filed Temporary		
25	Use Application # TU-25-06050 for a theatrical circus at Gulfstream Park, located at 901		
26	South Federal Highway, from February 19, 2026, to April 25, 2026, which is in excess of 30		
27	days, and which is considered a temporary use of a significant scale, with the potential to		
28	attract up to 5,000 people daily; and		
29	WHEREAS, the temporary use application has been reviewed by various disciplines		
30	for all temporary structures and electrical work associated with the temporary use, and any
