A RESOLUTION OF THE BOARD OF DIRECTORS OF THE GOLDEN ISLES SAFE NEIGHBORHOOD DISTRICT OF THE CITY OF HALLANDALE BEACH, FLORIDA, AUTHORIZING AWARD OF BID # FY 2024-2025-28, GOLDEN ISLES SAFE NEIGHBORHOOD DISTRICT (GISND) UNARMED SECURITY GUARD SERVICES, TO TOTAL PROTECTION SOLUTIONS, LLC, THE LOWEST RESPONSIVE BIDDER, IN A NOT TO EXCEED AMOUNT OF ONE MILLION SEVEN THOUSAND AND FOUR HUNDRED DOLLARS (\$1,007,400) OVER A PERIOD OF FIVE YEARS; AND PROVIDING AN EFFECTIVE DATE.

STAFF SUMMARY:

Summary:

This agenda item seeks the City Commission's approval to award Bid # FY 2024-2025-28 for unarmed security guard services to Total Protection Solution LLC, the lowest responsive and responsible bidder, in the amount of \$1,007,400. The contract will secure unarmed security services for the Golden Isles Safe Neighborhood District (GISND) for a period of five (5) years.

Background:

Staff conducted a competitive procurement process utilizing a piggyback of Miami-Dade County contracts for fiscal years 2024 and 2025 to ensure cost-effectiveness and compliance with procurement standards.

The GISND currently benefits from 24/7 security coverage provided at the GISND guardhouse. Unarmed security guards are responsible for controlling access by opening gate arms and verifying visitor identifications, playing a critical role in maintaining a secure environment for residents.

These security guards operate as a vital component of a broader, multi-layered security strategy for the Golden Isles neighborhood. This comprehensive plan also includes police off-duty details to provide additional law enforcement presence, License Plate Recognition (LPR) cameras installed at all neighborhood entrances and exits for vehicle monitoring, and public safety cameras strategically positioned throughout the district to provide surveillance. Together, these elements work in concert to promote a safe, secure, and welcoming community environment.

Awarding this contract ensures continuity of professional security services that are integral to the overall public safety framework of the Golden Isles Safe Neighborhood District.

Current Situation:

On July 31st, 2025, the City issued an Invitation to BID # FY 2024-2025-28, Golden Isles Safe Neighborhood District (GISND) Unarmed Security Guard Services. The notice for the Bid was sent to over seven hundred (700) vendors including vendors from the City's Vendor list and pertinent vendors that have a City Business Tax License to operate in the City. The Bid was advertised through the Hallandale Beach Chamber of Commerce website, City's website, DEMANDSTAR.com and City and HBCRA Social Media pages. The Bid was also advertised through the Miami Minority Business Development Agency Business Center, the U.S. Small Business Administration, and the Broward County Community Relations and Outreach Section Office of Economic and Small Business Development.

On August 13, 2025, at 11:00 am, a Non-Mandatory Pre-Bid meeting was held. Fifteen (15) firms attended the pre-bid meeting.

The Bid was due on September 3rd, 2025, and thirty-eight (38) vendors responded to the solicitation.

Cost Benefit:

By conducting BID # FY 2024-2025-28, and selecting Total Protection Solution LLC, the GISND is saving an average of \$67,957 per year from their current yearly cost for unarmed security guard services.
