RESOLUTION NO. 2022 - 149

A RESOLUTION OF THE MAYOR AND CITY COMMISSION OF THE CITY OF HALLANDALE BEACH, FLORIDA, AUTHORIZING THE 2022-23 RENEWAL TERM FOR STATE LOBBYIST SERVICES WITH BALLARD PARTNERS INC, IN AN AMOUNT NOT TO EXCEED FIFTY FOUR THOUSAND DOLLARS (\$54,000); AND PROVIDING AN EFFECTIVE DATE.

WHEREAS, on October 6, 2021, City Commission awarded RFP # FY 2019-2020-010 to Ballard Partners, Inc. via Resolution # 2021-133 in an amount not to exceed \$54,000 per fiscal year; and

WHEREAS, the current initial term of the Agreement was set to expire on October 5, 2022. Per Resolution No. 2021-133, each renewal term is subject to annual renewal approvals by the City Commission.

NOW, THEREFORE, BE IT RESOLVED BY THE MAYOR AND THE CITY COMMISSION OF THE CITY OF HALLANDALE BEACH, FLORIDA:

SECTION 1. The foregoing "Whereas" clauses are incorporated herein.

SECTION 2. The Mayor and City Commission hereby authorize the 2022-23 renewal of the agreement for State Lobbyist services with Ballard Partners for a total not to exceed fifty-four thousand dollars (\$54,000), and authorizing the City Manager to execute all related documents to effectuate the agreement(s).


SECTION 3. This Resolution shall take effect immediately upon its passage and adoption.


