5 OF THE CITY OF HALLANDALE BEACH, FLORIDA,
6 AUTHORIZING UTILIZATION OF THE AGREEMENT WITH
7 HD SUPPLY FACILITIES MAINTENANCE LTD THROUGH
8 OMNIA PARTNERS COOPERATIVE AGREEMENT FOR FY
9 2025-26 FOR CLEANING SUPPLIES, EQUIPMENT AND
10 CUSTODIAL RELATED SUPPLIES, SERVICES, AND
11 SOLUTIONS IN A NOT TO EXCEED AMOUNT OF SEVENTY
12 THOUSAND AND SEVEN HUNDRED SIXTY DOLLARS
13 (\$70,760); AND PROVIDING FOR AN EFFECTIVE DATE.

16 **WHEREAS**, pursuant to Chapter 23, Section 23-8 Exception to Bid Requirements, (6)
17 Bids and Contracts from Other entities, and Section 23-9 Cooperative Purchasing, the City
18 Manager is authorized to procure all supplies, materials, equipment, and services from other
19 governmental units, when the best interests of the City would be served subject to the
20 requirement that any purchase in excess of \$50,000 requires City Commission approval; and

22 **WHEREAS**, Staff desires to utilize the Omnia Partners Contract Number 2020002299
23 Agreement to purchase various supplies for FY 2025-26 outlined in a cost proposal that
24 includes, without paper towels, facial tissues, wipers, dispensing equipment, seat covers,
25 brooms and dust pans, can liners and restroom cleaners, and other related items in a not to
26 exceed amount of seventy thousand seven hundred sixty Dollars (\$70,760); and

28 **WHEREAS**, Staff recommends that the Mayor and City Commission find it in the public
29 interest to authorize utilization of the County of Fresno (California) Unified School District
30 agreement with HD Supply Facilities Maintenance LTD RFP 22-07 Custodial Supplies
31 through Omnia Partners cooperative agreement for FY 2025-26 for paper towels, facial
32 tissues, wipers, dispensing equipment, seat covers, brooms and dust pans, can liners and
33 restroom cleaners, and other related items in a not to exceed amount of seventy thousand
34 seven hundred sixty Dollars (\$70,760) and authorize the City Manager to execute all related
35 documents.

37 **NOW, THEREFORE, BE IT RESOLVED BY THE MAYOR AND THE CITY**
38 **COMMISSION OF THE CITY OF HALLANDALE BEACH, FLORIDA:**

40 **SECTION 1.** The foregoing "Whereas" clauses are incorporated herein.

42 **SECTION 2.** The Mayor and City Commission hereby authorize utilization of the HD
43 Supply Facilities Maintenance through Omnia Partners cooperative agreement for FY 2025-
44 26 for cleaning supplies, equipment and custodial related supplies, services, and solutions in
45 a not to exceed amount of seventy thousand seven hundred sixty Dollars (\$70,760), and
46 authorize the City Manager to execute all related documents.

48 **SECTION 3. Effective Date.** This Resolution shall take effect immediately upon its
49 passage and adoption.
