12	WHEREAS, during the 2025 legislative session, the Florida Legislature adopted
13	Senate Bill SB 784, thereby requiring that effective July 1, 2025, all plat applications, including
14	replats and plat note amendments, are to be processed administratively; and
15	
16	WHEREAS, the stated legislative intent of SB 784, now codified as Chapter 2025-164,
17	Laws of Florida, is to simplify and accelerate the approval of plats and replats throughout the
18	state by shifting responsibility from local governing bodies to administrative staff; and
19	
20	WHEREAS, pursuant to the City of Hallandale Beach ("City") Land Development
21	Code, plat and replat applications are required to be reviewed by the Planning and Zoning
22	Board and subsequently approved by the City Commission of the City of Hallandale Beach
23	("City Commission"); and
24	
25	WHEREAS, the aforementioned legislation now requires the governing body of a
26	municipality to designate an administrative authority to receive, review, and take final action
27	on such applications; and
28	
29	WHEREAS, in order to bring the City's procedures into compliance with state law,
30	Staff is recommending that the approval authority for plats and replats be delegated to the
31	"Director," as defined in Section 32-8 of the City's Land Development Code; and
32	
33	WHEREAS, Staff is concurrently processing an Ordinance to amend the City Land
34	Development Code and establish an administrative plat approval process consistent with the
35	provisions of Florida Senate Bill 784; and

37	WHEREAS, adoption of this resolution will serve as a temporary measure to ensure
38	that the City remains in compliance with state law and to allow staff to process applications
39	in accordance with the statutory requirements; and

12	interest to adopt this resolution until such time as the pending Ordinance amending the Code
13	has been passed and adopted by the City Commission.

55	authorized by this Resolution shall expire upon adoption of such Ordinance effectuating such
56	amendment to the City's Land Development Code to designate an administrative authority to
57	review and approve plat applications.
