SHORT TITLE:

A RESOLUTION OF THE MAYOR AND CITY COMMISSION OF THE CITY OF HALLANDALE BEACH, FLORIDA AUTHORIZING EXECUTION OF THE INTERLOCAL AGREEMENT (ILA) BETWEEN THE CITY OF HALLANDALE BEACH AND BROWARD COUNTY TO PROVIDE SURTAX FUNDING TO THE CITY FOR THE CITY HALL-004 SIDEWALK ADA IMPROVEMENTS PROJECT, CONSTRUCTION PHASE; AND PROVIDING FOR AN EFFECTIVE DATE.

STAFF SUMMARY:

Summary:

The Transportation and Mobility Department (TAM) staff seeks authorization to execute the Interlocal Agreement (ILA) between the City and Broward County to provide Surtax

funding for the City Hall-004 Sidewalk ADA Improvements (BC-HBEACH-FY2020-00001) Project. This ILA will grant the City \$2,713,559.06 towards the Construction Phase of the project.

Background:

The City Hall-004 Sidewalk ADA Improvements Project (Construction Phase) is included in the City's 5-Year Capital Improvement Plan (CIP). The project was submitted to MAP Broward for surtax funding, with a request of \$2,713,559.06 to support the Construction Phase of the Project.

The design of the project has already been completed, and the set of construction plans were approved by the Broward County Traffic Engineering Division on May 2, 2025.

Current Situation:

The City Hall-004 Sidewalk ADA Improvements Project Construction Phase has been determined to be statutorily eligible for funding and has received subsequent approval for funding by the Broward County Board of County Commissioners.

The purpose of this Agreement is to set forth the terms and conditions for the County to provide transportation surtax funding for the project and the terms and conditions for the municipality to complete the project. The City will implement the project, as funded by the County with surtax funding, in accordance with the terms of this Agreement.

Broward County provided the Project Specific Municipal Interlocal Agreement for surtax funding related to the City Hall-004 Sidewalk ADA Improvements Project Construction Phase, as detailed in Exhibit 2.

Sidewalk ADA improvements will be made to the locations below:

1. N.E. 12th Avenue from Hallandale Beach Boulevard to Moffett Street
2. Atlantic Shores Boulevard from N.E. 8th Avenue to N.E. 14th Avenue
3. Golden Isles Drive from Hallandale Beach Boulevard to the entrance to the Lake Point Tower Condominium
4. S.E. 2nd Street from S.E. 3rd Avenue to Old Federal Highway
5. S.E. 1st Avenue from S.E. 3rd Street to Hallandale Beach Boulevard
6. S.W. 3rd Street from S.W. 6th Avenue to S. Dixie Highway
7. N.E. 2nd Street from N. Federal Highway to N.E. 8th Avenue
8. N.E. 1st Court from N. Federal Highway to N.E. 8th Avenue
9. N.E. 1st Court from N.E. 10th Avenue to N.E. 12th Avenue

Why Action is Necessary:

Pursuant to Chapter 23, Section 23-6, Award of Contract, the City Manager shall have the authority to recommend to the City Commission award of contracts.

To receive surtax funding for the City Hall-004 Sidewalk ADA Improvements Project Construction Phase, the City Commission and the County Surtax Administration must approve the proposed ILA. The City's approval of the ILA must be completed via Resolution.

Cost Benefit:

The ILA between the City of Hallandale Beach and Broward County allows the City to receive transportation surtax funding for Hall-004 Sidewalk ADA Improvements Project Construction Phase. The total estimated cost for Hall-004 Sidewalk ADA Improvements Project Construction Phase is estimated \$2,713,559.06.


