18	WHEREAS, the City's master plan for development of a comprehensive
19	world class parks system was approved in 2014 by general obligation bond
20	referendum; and

22	WHEREAS, the Historical Village project, located at 324 SW 2nd Avenue,
23	provides for needed improvements to the Village and the 1924 Curci House, listed
24	in the U.S. National Register of Historical places; and
25	
26	WHEREAS, Chapter 23, Section 23-4, Competitive Bidding Required,
27	provides that all purchases of and contracts for equipment, supplies and
28	contractual services, when the estimated cost shall exceed \$50,000, shall be
29	based on competitive bids; and

31	WHEREAS, Staff recommends that the Mayor and City Commission award
32	RFP# FY2021-2022-011, Historic Village and Curci House Improvements, to the
33	most responsive vendor, Campus Construction Group, Inc., and (1) authorize the
34	City Manager to negotiate and execute an agreement for the bid amount of Four
35	Hundred Sixty-Two Thousand, Seven Hundred and Seventy-Seven Dollars
36	(\$462,777), (2) authorize a fifteen (15%) percent project contingency of Sixty-Nine

Thousand, Four Hundred Seventeen Dollars (\$69,417), permit fees of Fifteen 37 Thousand Dollars (\$15,000,) and staff cost of Fifty Thousand Dollars (\$50,000) 38 for a total not to exceed amount of Five Hundred Ninety Seven, Once Hundred 39 Ninety Four Dollars (\$597,194) and (3) authorize the transfer of additional funding 40 from the General Obligation Fund to cover all expenses for the Historic Village 41 project in the amount of One Hundred Ninety-Six Thousand, Two Hundred Twenty 42 One Dollars (\$196,221) and (4) and authorize the City Manager to execute any 43 other relating documents. 44

The Mayor and City Commission hereby award 49 RFP# FY2021-2022-011, Historic Village and Curci House Improvements, to the 50 most responsive vendor, Campus Construction Group, Inc., and (1) authorize the 51 City Manager and City Attorney to negotiate and execute an agreement for the bid 52 amount of Four Hundred Sixty-Two Thousand, Seven Hundred and Seventy-53 Seven Dollars (\$462,777), (2) authorize a fifteen (15%) percent project 54 contingency of Sixty-Nine Thousand, Four Hundred Seventeen Dollars (\$69,417), 55 permit fees of Fifteen Thousand Dollars (\$15,000,) and staff cost of Fifty Thousand 56 Dollars (\$50,000) for a total not to exceed amount of Five Hundred Ninety Seven, 57 Once Hundred Ninety Four Dollars (\$597,194) and (3) authorize the transfer of 58 additional funding from the General Obligation Fund to cover all expenses for the 59 Historic Village project in the amount of One Hundred Ninety-Six Thousand, Two 60 Hundred Twenty One Dollars (\$196,221) and (4) and authorize the City Manager 61 to execute any other relating documents. 62
