5 A RESOLUTION OF THE MAYOR AND CITY COMMISSION  
6 OF THE CITY OF HALLANDALE BEACH, FLORIDA,  
7 AUTHORIZING THE UTILIZATION OF THE OMNIA  
8 PARTNERS CONTRACT WITH W.W. GRAINGER, INC. TO  
9 PURCHASE SUPPLIES IN AN AMOUNT NOT TO EXCEED  
10 ONE HUNDRED AND FOUR THOUSAND, FIVE HUNDRED  
11 DOLLARS (\$104,500) FOR FISCAL YEAR 2025-26; AND  
12 PROVIDING AN EFFECTIVE DATE.

15 WHEREAS, Pursuant to Chapter 23, Section 23-8 (6), Exception to Bid Requirements,  
16 and Section 23-9 Cooperative Purchasing, the City Manager is authorized to procure  
17 supplies, materials, equipment and services from other entities, when the best interests of  
18 the City would be served, subject to the requirement that any purchase in excess of \$50,000  
19 requires City Commission approval; and

21 WHEREAS, the City actively participates in cooperative agreement purchasing in  
22 order to obtain cost savings and cost avoidances; and

24 WHEREAS, OMNIA Partners is the largest and most trusted cooperative purchasing  
25 organization for public sector procurement, and has brought together the nation's two leading  
26 cooperative purchasing organizations – National IPA and U.S. Communities – under one roof  
27 to form OMNIA Partners Public Sector; and

29 WHEREAS, Staff recommends that the Mayor and City Commission find it to be in the  
30 public interest to authorize the City to participate in OMNIA Partners Contract Number  
31 contract number 2018.000207 with W.W. Grainger, Inc. to purchase supplies, including  
32 without limitation electrical supplies, mechanical equipment, hand soap, pumps, light bulbs,  
33 and mats available from the store located in Pompano Beach or on-line in a not to exceed  
34 amount of One Hundred Four Thousand, Five Hundred Dollars (\$104,500) for Fiscal Year  
35 2025-26 and authorize the City Manager to execute all related documents to effectuate the  
36 purchase.

42           **SECTION 1. City Manager Authorization.**       The Mayor and City  
43 Commission hereby authorize the utilization of OMNIA Partners Contract 2018.000207 with  
44 W.W. Grainger, Inc. to purchase supplies, including without limitation electrical supplies,  
45 mechanical equipment, hand soap, pumps, light bulbs, and mats available from the store  
46 located in Pompano Beach or on-line in a not to exceed amount of One Hundred Four  
47 Thousand, Five Hundred Dollars (\$104,500) for Fiscal Year 2025-26, and authorize the City  
48 Manager to execute all related documents to effectuate the purchase.
