25	contracted pricing to make purchases on-line. Some of the purchases made by departments are
26	electrical adapters, ethernet cables, laptop batteries, audio auxiliary cables, drop cover cord
27	protectors, fiber optic cables, heavy duty pad locks, and other related items from Amazon
28	Business On-Line Marketplace; and

30	WHEREAS, for FY 23/24, the total expenditures requested by departments for Amazon
31	Services, LLC Amazon Business On-Line Marketplace exceed the fifty thousand (\$50,000) dollar
32	threshold; and

35	of Hallandale Beach to authorize the utilization of the requested contract.
