**SHORT TITLE:**

**A RESOLUTION OF THE MAYOR AND CITY COMMISSION OF THE CITY OF HALLANDALE BEACH, FLORIDA, AUTHORIZING UTILIZATION OF THE CITY OF FT. LAUDERDALE’S AGREEMENT WITH TROPIC FENCE INC., CONTRACT NUMBER ITB 12690-022, TO REPLACE THE SCAVO PARK OFF-LEASH DOG AREA FENCE IN A NOT TO EXCEED AMOUNT OF ONE HUNDRED, THREE THOUSAND, SEVEN HUNDRED AND TWENTY-SIX DOLLARS (\$103,726) DURING FY 2024-25, AND AUTHORIZE THE CITY MANAGER TO EXECUTE RELATING DOCUMENTS; AND PROVIDING FOR AN EFFECTIVE DATE.**

**STAFF SUMMARY:**

Summary:

The purpose of the agenda item is to request the City Commission to approve the attached resolution authorizing the City Manager to procure fencing from Tropic Fence, Inc. utilizing City of Ft. Lauderdale ITB# 12690-022 for a total amount not to exceed \$103,726 for the replacement of the dog park fencing at Joseph Scavo Park.

**Background:**

As part of the FY2025 budget process, park amenities were inspected for replacement and placed onto the Renewal and Replacement list. The dog park fencing at Joseph Scavo Park was identified for replacement. Parks staff worked to source vendors for the project and selected Tropic Fence Inc.

**Current Situation:**

The dog park fencing at Joseph Scavo Park needs replacement due to wear and tear and deterioration. Current fencing is only 4 foot high and poses a possible safety issue as it has become apparent that larger dogs have been seen to jump over the fence. Staff wish to replace the 4-foot fence with a 6-foot fence. Staff would like to move forward with replacement at this time

Staff seeks to piggyback the agreement between the City of Ft. Lauderdale and Tropic Fence Inc. via contract number ITB 12690-022. Under this agreement, staff will utilize funds in the amount of \$103,726, currently budgeted in FY 2024-2025 as part of the Renewal and Replacement Program. The initial term of the City of Ft. Lauderdale Tropic Fence Inc. contract was from September 6, 2022, through September 5, 2023. On August 17, 2023, the first renewal period was exercised and provided a new expiration date of September 5, 2024. On August 26, 2024, the second renewal period was exercised and provided a new expiration date of September 5, 2025.

**Why Action is Necessary:**

Pursuant to Code of Ordinances, in accordance with Procurement Code Section 23-8, Exception to bid requirements, (6) Bids and contracts from other entities, and Section 23-9. Cooperative purchasing, The City Manager is authorized to procure all supplies, materials, equipment and services from other governmental units, when the best interests of the City would be served subject to the requirement that any purchase in excess of \$50,000 requires City Commission approval.

**Cost Benefit:**

Replacing the dog park fence according to the City's Renewal and Replacement Program offers a strong cost benefit advantage by proactively addressing safety concerns and reducing long-term liabilities. A secure well-maintained fence helps prevent dog escapes and potential conflicts with other park users, supporting a safe and enjoyable environment. Additionally, maintaining the Park's infrastructure upholds public trust and encourages continued community use, reinforcing the value of the park as a community asset.
