10 TO CONDUCT BUSINESS IN THE STATE OF FLORIDA, TO
11 PURCHASE FOUR NEW POLICE PURSUIT VEHICLES FOR
12 A NOT TO EXCEED AMOUNT OF TWO HUNDRED FORTY -
13 SIX THOUSAND, SEVEN HUNDRED AND FIFTY-TWO
14 DOLLARS (\$246,752); AND PROVIDING FOR AN EFFECTIVE

18 **WHEREAS**, pursuant to the City of Hallandale Beach Code of Ordinances, Section
19 23-9, Award, (e), the City Manager may award procurements within the delegated spending
20 authority, and all other procurements, except emergency procurements, require commission
21 approval for award; and

23 **WHEREAS**, pursuant to the City of Hallandale Beach Code of Ordinances, Section
24 23-5 Competitive procurement required; Procurement Mechanisms, (a) (3) Cooperative
25 Purchasing, the City may utilize a variety of arrangements whereby two or more public entities
26 have the opportunity to purchase from the same supplier or multiple suppliers using a single
27 competitive procurement mechanism; and

29 **WHEREAS**, Ordinance No. 2025-011 authorized four police officer positions to be
30 assigned to a new zone in the southwest part of the City of Hallandale Beach in order to
31 improve response times, and provide a better allocation of resources and a more manageable
32 workload for officers; and

34 **WHEREAS**, Staff recommends that that the Mayor and City CommForty-Sixnd it to be
35 in the public interest to authorize utilization of Sourcewell cooperative contract #091521-NAF
36 with 72 Hour LLC d/b/a National Auto Fleet Group, which has selected Alan Jay Automotive
37 Management, Inc. to conduct business in the state of Florida, to purchase four new police

pursuit vehicles for a not to exceed amount of Two Hundred Forty-Six Thousand, Seven Hundred and Fifty-Two Dollars (\$246,752), and authorize the City Manager to execute relating documents.

NOW, THEREFORE, BE IT RESOLVED BY THE MAYOR AND THE CITY COMMISSION OF THE CITY OF HALLANDALE BEACH, FLORIDA:

SECTION 1. Whereas Clauses. The foregoing “Whereas” clauses are incorporated herein.

SECTION 2. Authorization. The Mayor and City Commission hereby authorize utilization of Sourcewell cooperative contract #091521-NAF with 72 Hour LLC d/b/a National Auto Fleet Group, which has selected Alan Jay Automotive Management, Inc. to conduct business in the state of Florida, to purchase four new police pursuit vehicles for a not to exceed amount of Two Hundred Forty-Six Thousand, Seven Hundred and Fifty-Two Dollars (\$246,752), and authorize the City Manager to execute relating documents.

SECTION 3. Effective Date. This Resolution shall take effect immediately upon its passage and adoption.
