RESOLUTION NO. 2025-**

**A RESOLUTION OF THE MAYOR AND CITY COMMISSION OF  
THE CITY OF HALLANDALE BEACH, FLORIDA, AMENDING  
AND REVISING FEES IN THE CITY FEE BOOKLET TO  
ESTABLISH AND IMPLEMENT APPLICATION AND ANNUAL  
PERMIT FEES FOR THE CITY'S URBAN CHICKEN  
PROGRAM; AND PROVIDING AN EFFECTIVE DATE.**

**WHEREAS**, in accordance with Article III, Section 10-61, of the City Code of Ordinances (the 'Code'), service or user charges or fees shall be set or amended by Resolution of the City Commission of the City of Hallandale Beach ("City Commission"); and

**WHEREAS**, on August 20, 2025, the City Commission adopted Ordinance 2025-013 to establish an Urban Chicken Program (UCP) within the City, thereby permitting residents to keep or raise chickens on developed and occupied single-family dwellings within residential zoning districts, provided that they first obtain a permit from the City; and

**WHEREAS**, to cover the staff cost of reviewing and inspecting properties that have applied for and received a UCP permit, the City Department of Sustainable Development (DSD staff recommends amending the City's Schedule of Fees and Charges, to establish and implement an application fee of \$25 and an annual permit fee of \$50 per property for the UCP; and

**WHEREAS**, Staff recommends that the Mayor and City Commission find it in the public interest to authorize the amendment to the City's fee booklet to include an application fee of \$25 and an annual permit fee of \$50 per property for the City's Urban Chicken Program

**NOW, THEREFORE, BE IT RESOLVED BY THE MAYOR AND CITY COMMISSION  
OF THE CITY OF HALLANDALE BEACH, FLORIDA:**

**SECTION 1. Incorporation of Recitals.** The foregoing "whereas" clauses are incorporated herein.

**SECTION 2. Implementation of Fees for UCP.** The Mayor and City Commission of the City of Hallandale Beach hereby approve the amendment to the City fee booklet to include

an application fee of \$25 and an annual permit fee of \$50 per property for the City's Urban Chicken Program (UCP).

**SECTION 3. Authorization of City Manager.** The City Manager is authorized to promulgate and publish such fees and charges and shall ensure the proper collection and accounting of all monies arising therefrom.

**SECTION 3. Effective Date.** This Resolution shall take effect immediately upon its passage and adoption.
