Application # V-24-5360 by the City of Hallandale Beach, Florida, requesting a variance from the minimum setback required for structures in the C-F, Community Facilities zoning district in order to construct an informational public announcement structure at the City Hall Complex. The subject property is located at 300-400 South Federal Highway.

- a) Section 32-155(d)(3), of the Hallandale Beach Zoning and Land Development Code, regarding the minimum front yard setback required for structures in the C-F District.
